

Notice on processing of personal data of customers and suppliers

(GDPR - General Data Protection Regulation - Reg EU 2016/679)

This notice is provided according to EU Regulation 2016/679 "General Data Protection Regulation" (hereinafter referred to as the Regulation), available on the website www.garanteprivacy.it and on the company website www.pisanobunker.com

We inform you that, for the management of existing or future contracts, Pisano Bunker will process your personal data, qualified as "personal data".

According to the law, this treatment will be carried out lawfully, fairly and in a transparent manner, protecting your privacy and your rights. According to the Regulation, we provide you with the following information regarding the processing of personal data.

Purposes of data processing

The processing of your personal data is aimed at the fulfillment of the obligations of national and international laws, connected to the contractual relationship, as specified below:

- Fulfillment of legal obligations deriving from an existing contract.
- Fiscal, customs and public security obligations.
- Management of suppliers and customers (management of contracts / orders / agreements, control of financial reliability and solvency, control of supplier performance and customer satisfaction and related statistical processing).

For the management of the contractual relationship, Pisano Bunker will not process data belonging to the "special categories" referred to in art. 9 of the Regulation.

Methods of data processing and period of data storing

The data will be processed mainly with electronic and IT tools and stored on both computer and paper supports, to which only the personnel in charge will be able to access, in compliance with the security measures defined by the company.

Your personal data will be kept for five years from the conclusion of the last contract with Pisano Bunker Srl, with the exception of those for which, by law or at your request, different retention times are / will be provided.

Nature (mandatory or voluntary) of providing data

The provision of your data is mandatory for all that is required by the fulfillment of laws and contractual obligations and therefore any refusal to provide them could make impossible to continue the relationship.

Recipients to whom personal data may be disclosed We inform you that the personal data you provided or acquired during the existing or future contracts may be disclosed externally to fulfill the obligations of the law / contract and/or operational requirements relevant to the contract.

The data may be communicated and/or transmitted abroad, both within the E.U. that extra E.U., exclusively for purposes related to the existing contract.

Personal data can be disclosed to the following recipients:

- Public and private bodies for the fulfillment of legal obligations.
- Consultants in legal, tax and accounting matters.
- Credit and insurance institutions.

Your data will also be communicated to the company employees for processing activities (Company's personnel has been adequately trained on personal data protection).

Rights of the data subject

Based on the Regulation, you have the right to:

- Be informed about the processing of your personal data (through this "Notice").
- Obtain Your personal data from the "Data Controller".
- Obtain, upon your indication, the rectification or integration of your personal data.
- Obtain the erasure and/or restriction of processing of your data.
- Object for legitimate reasons to the processing of data, subject to the limits established by law.

Finally we inform you that you can lodge any complaints regarding the processing of Your personal data to the Supervisor Authority.
